

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <http://www.shiningstarsutah.com/> and Shining Stars Academy, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Shining Stars Academy, LLC include <http://www.shiningstarsutah.com/> and Shining Stars. The Shining Stars website is a News and Information site. By using the Shining Stars website, you consent to the data practices described in this statement.

Collection of your Personal Information

Shining Stars may collect personally identifiable information, such as your:

- Name
- E-mail Address
- Phone Number

Shining Stars encourages you to review the privacy statements of websites you choose to link to from Shining Stars so that you can understand how those websites collect, use and share your information. Shining Stars is not responsible for the privacy statements or other content on websites outside of the Shining Stars website.

Use of your Personal Information

Shining Stars collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Shining Stars may also use your personally identifiable information to inform you of other products or services available from Shining Stars and its affiliates. Shining Stars may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Shining Stars does not sell, rent or lease its customer lists to third parties.

Shining Stars may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Shining Stars, and they are required to maintain the confidentiality of your information.

Shining Stars will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Shining Stars or the site; (b) protect and defend the rights or property of Shining Stars; and, (c) act under exigent circumstances to protect the personal safety of users of Shining Stars, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Shining Stars. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Shining Stars website.

Use of Cookies

The Shining Stars website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Shining Stars pages, or register with Shining Stars site or services, a cookie helps Shining Stars to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Shining Stars website, the information you previously provided can be retrieved, so you can easily use the Shining Stars features that you customized.

- SSL Protocol
